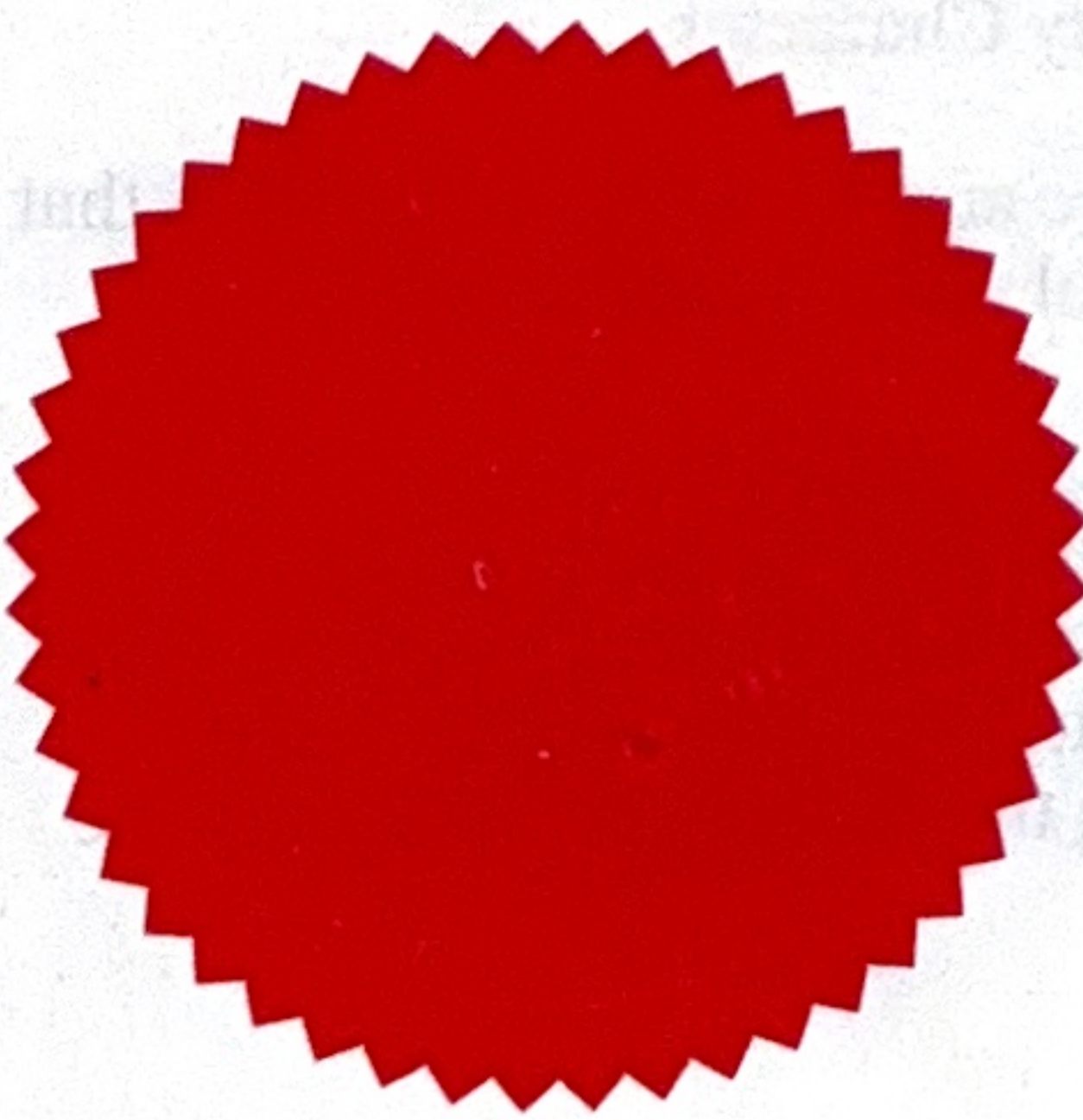
APPENDIX-IV

AFFIDAVIT
